



College and Career Ready Performance Index (CCRPI) is Georgia's statewide accountability system. The CCRPI assesses how well students are prepared for college and careers, and ensures that schools are focused on improving achievement among all students. The index measures student achievement on indicators such as content mastery, student growth on progress, subgroup performance on closing gaps, and various areas including Lexile performance, attendance, and other academic based measurements. Schools earn CCRPI points based on indicators that vary by grade and school level and align with measures of college- and career-readiness. Each individual component score is on a scale of 0-100. #### Magnet School and Specialized Program Agreement of Understanding

By signing my name below, I indicate that I have read the Agreement of Understanding and I acknowledge the conditions of acceptance. The privilege of attending this school rests upon the personal responsibility of the child and parent. This agreement of understanding will be renewed each year.

#### All Magnet School and Magnet Program Students:

- 1. I understand my child is expected to attend school daily, to arrive by the school's scheduled start time, and to remain throughout the scheduled hours.
- 2. I understand my child is to cooperate and conduct themselves with teachers, other adults, and classmates in a manner showing respect to all persons.
- 3. I understand my child is to complete all required work, including homework and work missed.
- 4. In order to remain enrolled in a magnet school or program, I understand that, in grades K-3, it is my child's responsibility to maintain an overall rating of a 2 in language arts and math. In grades 4-8 it is my child's responsibility to maintain an overall 75 average in academic subjects (language arts, math, science, and social studies) and not have a yearly average below a 70 in any subject. In grades 9-12, it is my child's responsibility to pass each subject with a 70 or above. Students in grades K-3 having a yearly rating below a 2 in ELA and Math or in grades 4-8 having a yearly average below 70 in any class or having a cumulative average below 75 in the core classes will be required to return to the student's zoned school at the end of the year. Students in grade 9-12 having an end-of-course average below 70 are required to attend summer school in order to remain on track for graduation.
- 5. I understand my child is to respect and care for all equipment, supplies, and school property they use.
- 6. I understand that if I choose to remove my child, or if I am asked to remove my child from the school, my child may not reenter unless there are rare and extenuating circumstances as approved by the Assistant Superintendent or determined by the Board of Education. [Note: Students who withdraw due to military transfers may apply for re-admission through the annual magnet application process.]
- 7. I understand my child must adhere to all school policies and Richmond County Board of Education policies, including but not limited to the Code of Student Conduct and Discipline as well as attendance policies.
- I understand if either the student or parent/guardian, or both, ceases to be a resident of Richmond County, the school shall be promptly notified, to allow a prompt determination as to whether the student remains eligible to attend the selected school.
- 9. I understand that my child will be enrolled as a full-time student at RCTCM for the entire 2024-25 academic year subject to the provisions of this Agreement of Understanding. My child must demonstrate acceptable performance in order to remain in the magnet school or specialized program. Failure to meet any of the criteria may result in the student being dismissed from the magnet school or specialized program.
- 10. I understand that my child is not eligible to participate in athletic and/or extra-curricular activities at my child's zoned school or any other Richmond County School other than the school in which my child is enrolled as a full-time student.

#### Conditional Early Acceptance Additional Requirements:

- 11. I understand my child must maintain an 80-final average in all core subjects (math, reading/ELA, science, social studies) for the 2023-24 school year. Failure to maintain an 80-final average in each subject for 2023-24 will result in a withdrawal of your child's admissions offer.
- 12. I understand if I fail to provide appropriate proof of residency documents and a birth certificate during on-site registration in March, my spot will be forfeited and offered to the next person on the waiting list.

I promise my child will be in regular attendance, cooperative, respectful of people, and studious in order to remain enrolled. The student hereby agrees to work with the parents and staff in compliance with the above responsibilities.

#### CELL PHONES AND ELECTRONIC COMMUNICATION DEVICES POLICY CONFISCATION AND PICKUP

#### Circle Offense

**DISCIPLINE**: Due to the potential disruption a cell phone and electronic communication devices may cause to the instructional environment and safety of the school, the disciplinary actions and consequences for violation of this rule are as follows:

**First Offense:** The first offense will result in the electronic device being confiscated, to be picked up by the student or parent at the end of the same school day. The incident will be recorded in the student's discipline record within the student database (e.g., Infinite Campus). **Student or Parent May Pickup** 

Second Offense: The second offense will result in the electronic device being confiscated, to be picked up by the parent on the Friday following confiscation, at the specific time designated by the school. The incident will be recorded in the student's discipline record within the student database (e.g., Infinite Campus). Only PARENT May Pickup

**Third Offense:** The third offense will result in the electronic device being confiscated, to be picked up by the parent on the Friday following confiscation, at the specific time designated by the school. The student will receive one day of in-school suspension (ISS). The incident will be recorded in the student's discipline record within the student database (e.g., Infinite Campus). **Only PARENT May Pickup** 

**Fourth Offense:** The fourth offense and thereafter will result in the electronic device being confiscated for ten (10) school days, and the parent must schedule a conference with an administrator to retrieve the electronic device. The student will receive three days of in-school suspension (ISS). The incident will be recorded in the student's discipline record within the student database (e.g., Infinite Campus).

Further incidents may result in the student losing the privilege of bringing electronic devices on campus, in-school suspension, out of school suspension, and any other forms of discipline deemed appropriate under the circumstances.

Noncompliance: All administrators, teachers and/or staff members are authorized to confiscate cell phones, electronic communication devices and/or accessories any time a student is in violation of the Cell Phone/Electronic Communications Device policy. A student's refusal to surrender his/her electronic device(s) to school personnel will be considered noncompliance and insubordination, resulting in two (2) days of out of school suspension, and any other forms of discipline deemed appropriate under the circumstances.

#### Note: These progressive discipline steps in no way diminish the discretion of the school administrator, who has the right to issue more severe discipline depending upon the facts and circumstances.
