What is Title I?

Hornsby Middle School is identified as a Title I school as part of Every Student Succeeds Act (ESSA). School Plan for Shared Student Achievement

What is it?

This is a plan that describes how Hornsby Middle School will provide opportunities to improve family engagement to support student learning. Hornsby Middle values the contributions and involvement of parents and family members to establish an equal partnership for the common goal of improving student achievement. How is it revised?

Hornsby Middle School invited all parents to attend our annual School Forum this year to review and revise this parent and family engagement policy, as well as the schoolwide plan, our school-parent compact, and the family engagement budget. The plan is posted on our school website for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey online to ask parents for their suggestions on the plan and the use of funds for family engagement. Parents and family members can also give feedback during several parent meetings and activities during the school year. If the plan is not satisfactory to the parents of participating children, the school will submit any comments to the district office.

Who is it for?

All students participating in the Title I, Part A program, and their families are encouraged and invited to fully participate in the opportunities described in this plan. Hornsby Middle will provide full opportunity for the participation of parents and family members with limited English, with disabilities, and of migratory children.

Where is it available?

At the beginning of the year, the Richmond County Parent and Family Engagement Plan is included in the student code of conduct book that is given to all students. Hornsby's Parent and Family Engagement Plan will also be posted on the school website and distributed at the Title I Annual Meeting. Parents can also retrieve a copy of the plan in the Parent Resource Center.

- School Improvement Plan Goal #3: By May 2026, increase student attendance to 93% and teacher attendance by 10%
