Course Description

The purpose of this course is to provide a strong academic background for motivated, responsible students who are reading and writing on or above grade level. The course centers on a study of United States Government, beginning with various theories of government and working our way up to government on the local, state, and national level. Vocabulary study is mandatory.

This course follows a routine cyclical pattern for each unit. Lecture \rightarrow Activity \rightarrow Lecture \rightarrow Activity \rightarrow Project \rightarrow Test.

Late Work

Grades in my class are weighed in the following manner:

MAJOR (Tests, Projects, Essays, Papers) 40% MINOR (Classwork, Quizzes) 60%

Reassessment

Students may request to be reassessed on Major Tests. Students must follow the ARC Reassessment Policy and submit a written reassessment request/plan to their teachers AND parents. Any reassessment on Major Grades must be done after school and within seven days of the original assessment, at the discretion and convenience of the teacher.

Final Exam

There is no EOCT or Milestone Test for this course, however there IS a final exam. Students who have a final average of 90 or better at the end of the semester may exempt the final. I will not award unearned points to boost your grade; if you do your best, you will succeed in this class.
