Objective and Course Content

Upon completion of this course, students will be able to:

1. Explain the purpose of FFA and list the benefits of being a member of the National FFA Organization.
2. Develop knowledge of leadership and list characteristics of a good leader.
3. Develop plans for a supervised agricultural experience program.
4. Identify four divisions of horticulture.
5. Develop a working résumé and cover letter.
6. Explain three phases of plant life.
7. Determine warm and cool season plants.
8. Explain plant germination and plant nutrients.
9. Discuss transpiration and respiration.
10. Explain major parts of the plant and the functions of each (ex: roots, stems, leaves, flowers, fruits, seeds).
11. Use and interpret data collection for greenhouse use.
12. Participate in the Annual Greenhouse Bedding Plant Sale (*large portion of grade*).

Bathroom Rules

Absences

Make-up/Late Assignments

All missing work will receive a grade of "M" until it is completed. In the case of an EXCUSED absence, it is on the student to ask the teacher for any missing work. In relation to an excused absence, per BOE policy, a student has 5 class days to complete and return in any missed assignment. 5. Participate in Annual Greenhouse Bedding Plant Sale (3 hour minimum)/GA National Fair Display.
