  - 1. The street in front of the school is one way during drop-off (7:30-8:30) and pick-up (2:45-3:45).
  - 2. Car Rider traffic should use Wingfield Street to access Richmond Avenue and follow the drive on the left side of the school to drop off and pick up your student. This will allow you to exit to Wrightsboro Road.
  - 3. The circle drive up front is for **Buses and Daycare Vans only**.
  - 4. Please do not park along the yellow curb in front of the school. There are a few marked spots along Richmond Avenue. Those spots are located on the right side of the street.Please park in the back of the building if you need to come inside the school.

**Children are considered tardy after 8:25**. Parents will need to bring their child into the office to sign the child in after this time. **Leaving before 3:00 is considered a tardy**.

Please keep in mind that we dismiss the students according to what is written on their registration forms. If there is a change, please send in a signed written notice. Phone calls are not sufficient to ensure the safety of our students.

#### Attendance and Tardies

Students who are absent from school are **required to bring a written excuse for the absence** their first day back at school. An absence is either excused or unexcused. Students must attend school for at least one-half (11:30) of the day in order to be counted present.

#### Tardies

The accumulation of unexcused tardies will warrant disciplinary action. Leaving school for

unauthorized purposes before the end of the instructional day will be counted as a tardy. See page 13 of Code of Student Conduct and Discipline for Tardy Consequences. Classroom Visitations/Conferences

Parents are encouraged to visit classroom instruction and attend any presentations. If during your visit, you have questions, please arrange for a conference. Please request a conference appointment in advance in order to avoid conflicts in the teacher's schedule. We encourage teachers to confer regularly and greatly appreciate interest and participation.

#### Communication

Information from the school is sent home as the need arises. Teachers send home papers weekly so please check your child's book bag daily for notices and homework. #### Make-Up Assignments

Class work missed due to excused absences including short-term suspensions may be made up within one week of the student's return. It is the student's responsibility to get the make-up work from the teacher. Parents will need to make arrangements with the teacher for make-up assignments.

#### Medications

The policy of the Richmond County Board of Education is that all medications be administered at home, whenever possible. **If medication must be administered at school, specific conditions must be met and a complete medication form must be filled out**. Please contact our school nurse for any concerns or questions.

#### Nutrition

Breakfast and Lunch are at no charge. Breakfast begins at 7:45 each morning until 8:15.

#### Parties

There will be a Christmas Party and an End of the Year Party for each class from 1.45–2.45 on the last day before the holiday or summer vacation. While birthday parties are not permitted at school, parents may bring cupcakes during the lunch period to honor a child having a birthday. Please send a note to the teacher so that she will make arrangements. If you do not want your child to participate in any celebrations, please just send a note to your child's teacher.

#### Transportation

In order to continue riding the school bus, certain rules must be followed to ensure the safety of those riding the bus. Failure to comply with those rules can result in suspension from the school. The bus driver will make a written referral to the principal for misconduct on the bus. The following consequences will be applied.

1<sup>st</sup> Offense: Verbal warning and notice to parents. Parents will need to return the form

signed.

- 2<sup>nd</sup> Offense: Bus Safety Class and notice to parents. Parents will need to return the form signed.
- 3<sup>rd</sup> Offense: Suspension from the bus. (1-2 days)
- 4<sup>th</sup> Offense: Suspension from the bus. (3–5 days) and a required conference with parents and principal.

Fifth Offense: Suspension from the bus. (5-10 days)

# If a student continues to misbehave on the bus then he or she will be suspended from the bus for the rest of the year.

#### Withdrawal

If it becomes necessary to transfer your child to another school, notify your child's teacher and our front office at least 24 hours in advance. All library books and textbooks must be returned and any debts paid before withdrawal forms can be completed.
