

How does the school spend funds?

Title1 Part A

Title1 funds are authorized and can be used to provide additional staff, professional development; instructional materials; improve curriculum; enhance parental involvement; extended learning time for students who need extra help; and provide other activities that are tied to raising student achievement on the State's academic achievement standards.



Requirements For a Title 1 Schoolwide Program

- •A Title 1 school is eligible to become a Title 1 Schoolwide Program when the poverty level, (determined by free and reduced meal counts, Aid for Dependent Children [AFDC], census, or Medicaid) is at or above 40%.
- •Serves all students in the school, but requires special focus for lowest achieving students
- Combines federal funds into total school budget
- •Is supplementary. The amount of Federal funds used in a schoolwide program must be supplemental to the amount of State and local funds the school would otherwise receive.

The school-parent compact is an agreement that outlines how **parents**, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and **parents** will build and develop a partnership to help children achieve the state's high standards.

Parent Right to Know

Parents have the Right to request teacher qualification

Notify if child has been taught by a non-highly qualified teacher for more than four weeks

- -Letters are sent home to parents at the beginning of school year
- -Letters were given out to parents/guardians at open house
- -And will be given out as handouts through-out the year.



Collaborative Effort

Planning is a method for building a community to support school change and should involve school staff, **parents**, and the community.



Parent Decision Making Opportunities

Parents have a right to:

- Request opportunities for regular meetings
- Formulate and share suggestions
- Be active participants in the educational decision making process (via Title1 school-wide committee, school council meetings, PTA, etc.)
