School Parent and Family Engagement Policy 2020-2021

JOINTLY DEVELOPED

The Alternative School @ Morgan Road will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

A meeting will be conducted annually to include parents in the planning process for the school program and revision of the school-parent compact. In addition, an initial meeting will inform parents of the school's Title 1 Plan, its requirements and their right to be involved in the program. Other meetings such as parent days and Open House will also be conducted to inform parents of their students' progress and plan for intervention when needed.

The Innovation Academy will assist parents in understanding the state of Georgia's academic content standards. Title 1 funds will be provided for transportations, childcare and home visits as needed

ANNUAL TITLE I MEETING
