- 1) I certify, by my signature below, that the above information is true.
- 2) I agree that my being allowed to operate and to park a vehicle on school property is conditioned on my willingness to have that vehicle subject to search, as hereafter defined by school administrators, at any time the vehicle is on school property.
- 3) In addition, the student and parent or guardian in making this parking permit application, agree and affirm in writing that school authorities (principals and their designees) may search my vehicle where there is:
  - a) Consent of the student, contraband in plain view, if evidence or contraband is discovered while responding to an emergency or during the handling of a traffic violation;
  - b) Where the student is in the parking lot without written permission or during non-authorized hours;
  - c) In all circumstances where the school official acts to protect the life, property and health of students, teachers or other individuals
- 4) Further, the undersigned student and parent or guardian recognize that the Board of Education has the responsibility to insure the safety of all students and provide a wholesome learning environment. Thus, school authorities are additionally hereby given permission to conduct random suspicionless searches, in the school parking lot or on school property, of my vehicle without warrants; and, in the discretion of school authorities during said searches, to utilize the assistance of canines trained to detect drugs, explosives or weapons.
- 5) I also understand that as a student it is my responsibility to obey the posted speed limit on school grounds, to properly display the school parking permit, to park in designated areas, to make certain that the car does not contain drugs, weapons, or other articles prohibited by law or school rules, and to maintain legally required insurance on the vehicle. Finally, I understand that any violation of this agreement or other school rules, including but not limited to the absence and tardy rules, can lead to the revocation of all parking privileges. I further understand that motor vehicles in violation of this regulation may be subject to towing.
