


Image 1 Sustained Investigation

Process(es): I built, stretched, and primed my canvas, used an acrylic base, then painted the portrait using oil



Process(es): I freehanded a sketch with pens, then added ink for color, and finished with an acrylic background






Image 9 Sustained Investigation

Process(es): I sketched self portraits using watercolor, then used ink pens to compliment it



Response:

My artwork inquires the disorienting process when recovering from mental illness. I execute it by exploring different fantasy-like patterns, objects, and lighting that conveys an altered connection between self perception and the outside world.

I associate certain materials and patterns to certain types of emotions, such as repetitive and small strokes representing anxious feelings, like in images 2, 7, 8, and 9, and loose and gentle painting strokes to represent deep and dreamy emotions, like images 4, 5, 6, and 11. I often experimented with lights and darks to find the divide between emptiness and strong, powerful thoughts. In some pieces, I combined the feelings of anxiety with feelings of comfort to show that there is a struggle to find normality during recovery, like in images 3 and 10. My overall meaning throughout my artwork is that recovery is never linear.
