Butler utilizes the Infinite Campus Parent Portal, as a mechanism for real-time student achievement reporting for classroom level assessments and tasks. In addition to this mechanism each 4½ weeks, progress reports are distributed to keep parents abreast of student progress and performance. For each of these progress reporting times, Butler hosts a face to face parent night to work with parent on strategies to help students to be successful in high school. For standardized assessments, parent informational sessions are available to help parent to interpret the data.

The school utilizes the tools from the data protocol to analyze data.
