DISCRETIONARY SCHOOL PARENT AND FAMILY ENGAGEMENT POLICY COMPONENTS

- Involve parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training.
- Provide necessary literacy training for parents from Title I, Part A funds if the school has exhausted all other reasonably available sources of funding for that training.

Finally, there will also be, upon proper training, opportunities for parent volunteers to assist in maintaining our school clothing closet and food pantry.

The above indicated discretionary items highlighted will be implemented by working with community-based organizations. For example, SPARK, Shaping Lives, and Strengthening Families are examples of such firms. Furthermore, they will partner with teachers, faculty and staff, administrators, as well as tutors on a weekly basis to assist students academically as well as with social concerns. Likewise, they will also offer students opportunities to visit various places within the community to gain additional exposure. Otherwise, many students, due to socioeconomic factors, might not be afforded such a chance to discover the world beyond their immediate neighborhood. Finally, they will foster
