### Documents to Complete:

1. Certification Update\_Application – must be completed for renewal of ANY field
2. Fingerprint form: *If Clearance Certificate is expiring*
3. Verification of Lawful Presence: **If VLP Status has not been validated**

### Fingerprinting (FBI background check) – Fee: \$41.00 (money order or cashier's check only payable to Richmond County Board of Education)

Visit the School Safety and Security, 864 Broad Street, 1<sup>st</sup> Floor, between 10 am-12 noon or 2-4 pm daily to be fingerprinted.

Upon receipt of your complete renewal packet, Human Resources will verify an acceptable criminal background check and completion of fingerprints before applying for certificate renewal with the Georgia Professional Standards Commission.
