SUBJECT: Special Education Speech Services  
Request for Qualifications #25-183

The Special Education department solicited qualifications to cover both Speech Language Pathologist (SLP) and American Sign Language Interpreter (SLI) services. Currently, the district has 2,000 plus enrolled students that receive these services. Depending on the level of need, students can receive 30 to 90 minutes of therapy per week. Statements of qualifications were received from thirty-six providers of one or both services requested in the solicitation.
