Ten vendors submitted bids for the Double Stack Electric Combination Oven/Steamer to be installed at Wilkinson Gardens Elementary School. Five of the ten vendors did not bid as specified. These five vendors bid a single oven instead of a double stack oven. These five bidders are marked on the attached tally as bids being rejected. All individual prices, brands, and models are listed on the attached tally sheet.

Singer T & L bid three models for us to choose from. Their lowest bid (Option "A"is for a "Rational/ICC6-Full E" brand/model. We do not currently have any of these in our school system. Singer T & L second option was for a "Blodgett/BlCT-62-62E". Nutrition states that this item would be in the best interest of our school system because we already have this brand in several schools and if the need arises for repair after the warranty is expires our maintenance technicians are already familiar with this brand/model.

Administration recommends the award go to Singer T & L located in Simpsonville, South Carolina for their Option B. This is the lowest price meeting specifications.
